New users should use the password agdpace and then change it for better security. Next select *Education & Events* from the home page, then *PACE* from the menu bar on the left and then *Submit CE Rosters* from the expanded menu bar on the left.

If you choose not to use the electronic roster submission tool, use the AGD's standardized roster to submit the names and ID numbers of <u>AGD member attendees</u> to the AGD Membership Services area. Please *do not include the participant's address*, *e-mail or home phone number on these rosters*, as copies of the roster will be attached to each participant's record. <u>All participants</u> must be issued a CE attendance verification form or letter for their personal records. Sample rosters and verification forms can be found in the PACE section of the website under *Sample Documents for Approval*.

Approved providers have the obligation, if requested, to allow one monitor at least one time per year to monitor one of their programs. Details on the AGD monitoring program can be found in the PACE Program Guidelines.

The AGD e-mails approval renewal notices to providers approximately eleven months and six months before their expiration date. All nationally approved PACE Providers are required to pay an annual non-refundable maintenance fee in addition to the non-refundable application fee.
